GRADUATE PROGRAMS: SPOTLIGHT BRAZIL

Pace University began its joint-programs in Brazil in the 1960s under the leadership of Professor Jordan Young. The Elisabeth Haub School of Law has since participated in programs in all parts of Brazil and is an active member of the Brazilian-American Chamber of Commerce. Located in White Plains, New York, 30 minutes from New York City, the Law School has a comprehensive and integrated curriculum in environmental law and is one of the nation's highest ranked academic centers offering Master of Laws & Doctor of Juridical Science degrees. Additionally, Pace trains foreign attorneys to be licensed in the United States.

BRAZIL-AMERICAN INSTITUTE FOR LAW AND ENVIRONMENT (BAILE):

The Brazil-American Institute for Law and Environment (BAILE) is a non-profit research, teaching and policy center dedicated to building and fostering the relationship between the United States and Brazil in their shared goal of environmental protection and sustainable development. BAILE's mission is to work to improve environmental protection and to foster more effective environmental laws through research, education and advocacy. The Institute encourages international cooperation to stimulate and refine progressive environmental law in both countries.

Through BAILE, Pace offers a unique combination of classroom and field training. Pace has extensive relationships with many Brazilian law schools and universities, allowing us to engage our students in research and exchanges with our partner schools in Brazil. Each year,

students travel to Brazil to experience the environmental issues they have studied in the classroom first hand. Students visit many unique environmental regions of Brazil and attend legal meetings in Rio de Janeiro and other parts of the nation.

Professor David N. Cassuto, a Portuguese speaker, has been in charge of Pace's Brazil programs since 2003. He is the founder and Executive Director of the Brazil-American Institute for Law & Environment (BAILE). Professor Cassuto has been a Fulbright Fellow and visiting professor at the Getulio Vargas Foundation School of Law (FGV Direito Rio)
