### IV. DEVELOPMENT UPDATE

- New Development Officer, Larry Curran, joined the call at this point and shared his fundraising background. He hopes to meet with committee members individually by phone or in person.
- The 24<sup>th</sup> Annual Law Leadership Awards Dinner is scheduled for Thursday, March 7. Arianne provided a reminder about this event. Her hope is to have a special ticket rate for the Alumni Association Board of Directors. She will check with organizers to see if this is possible.
- Last year's giving and this year's efforts the number of alumni who have contributed this year has not increased but they are being more generous with their donations.
- Arianne reported that plans are still being made for Giving Tuesday and other fundraising efforts and will be unveiled as dates get closer.

## V. DEVELOPMENT UPDATE

# VII. COMMITTEE REPORTS

#### 1. Nominating Committee:

- Mike Frankel reported the committee had discussed the best way to increase the number of Board member candidates.
- There are currently 4-5 candidates who have expressed an interest in joining next year's Board.
- He suggested being flexible with the December 1 deadline while trying to find alumni interested in serving.
- After the meeting, online posts recruiting interested candidates were added to both the PLS LinkedIn group and the P.L.A.N. Facebook group.

### 2. Social Committee:

- Jennifer Gray reported that the next P.L.A.N. event will happen in Manhattan during the NYSBA's annual meetings, January 14-18. The last couple of years the law school has rented out the second floor of the Old Castle Pub, just down the block from the Hilton, and that has worked out very well.
- Halloween party was held at the school on October 30<sup>th</sup>, at which the Board had a table staffed by Sandy Forster, Joe Martin and Mark Meeker
- Arianne reminded the Board about the upcoming events and encouraged them to support the events if possible:
